ORDER:

The following notification shall be published in the Extra-ordinary Issue of the Official Gazette: -

NOTIFICATION

WHEREAS section 14 of the Electricity Act, 2003 (Act No.36 of 2003) confers the status of a Licensed Licensee upon the Government of Puducherry;

AND WHEREAS Section 42(5) of the Electricity Act, 2003 provides that every distribution licensee shall, establish a forum for redressal of grievances of the consumers in accordance with the guidelines as may be specified by the State Commission;

AND WHEREAS the Joint Electricity Regulatory Commission for the State of Goa and Union Territories has notified Regulations called the Joint Electricity Regulatory Commission (Establishment of Forum for Redressal of Grievances of Consumers) Regulations, 2009 in the Gazette of India dated 06<sup>th</sup> August, 2009;

AND WHEREAS Regulation 3 of the Joint Electricity Regulatory Commission (Establishment of Forum for Redressal of Grievances of Consumers) Regulations, 2009, provides that the Forum shall consist of three Members, including the Chairperson. The Licensee shall appoint the Chairperson and one Member of the Forum on a full time basis and the Commission shall nominate one Independent Member;

AND WHEREAS the Commission vide its Order No. 6/2/2009-JERC/26 dated 25/11/2009, had appointed Thiru G. Krishnamoorthy, No. 48, 11<sup>th</sup> Cross Road, First Floor, Rainbow Nagar, Puducherry - 605011, as the Independent Member of the Forum, familiar with consumer affairs;

NOW THEREFORE in compliance of the provisions of the Electricity Act, 2003 and the Regulations framed thereunder, the Lieutenant Governor, Puducherry is pleased to constitute the Consumer Grievance Redressal Forum with the following Chairman person/ Member:-

1. Thiru O.M. Chandrasekar, District Judge of the Tamil Nadu State Judicial Service (Retired) as Chairperson; and
2. Thiru K. Ramasubramanian, Executive Engineer, Electricity Department, presently working as Executive Engineer in the Perunthalaivar Kamaraj Medical College & Research Institute, Puducherry on deputation basis as Member of the Forum.

The terms and conditions of service of the Members and the functions of the Forum shall be as per the regulations of Joint Electricity Regulatory Commission (Establishment of Forum for Redressal of Grievances of Consumers) Regulations, 2009.

The Consumer Grievances Redressal Forum (CGRF) shall deem to have been constituted for the Union Territory of Puducherry from the date of assumption of office by the Chairperson, which shall not be later than the 31<sup>st</sup> of May 2010.


