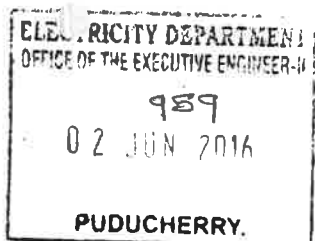

**Sub: Selection of Commission's Nominated Member for the Consumer Grievance Redressal Forum (CGRF), Electricity Department-Puducherry**

Sir

This has reference to JERC advertisement for the post of Nominated Member, CGRF-Puducherry which was uploaded on the website on 23.12.2015 and window notice was also published in eight regional newspapers on 29.12.2015. The last date of receipt of the applications was 01.02.2016.

The Commission received four applications for the above post. The Commission hereby selects Sh. I Alwin Imanuel Jayaprakash as Nominated Member of JERC for the State of Goa & UTs as per the provisions of JERC (Establishment of Forum for Redressal of Grievances of Consumers) Regulations, 2009 and its First and Second Amendment Regulations, 2013 and 2015 respectively for the CGRF, Electricity Department, Puducherry on the following terms & conditions:-

1. The period of the said appointment shall be 3 years w.e.f. the date he assumes the office or attains the age of 65 years, whichever is earlier.
2. He shall administratively report to Chairperson, CGRF, Puducherry.
3. He shall be entitled to a monthly consolidated remuneration of Rs.45,000/- (Rupees Forty Five Thousand only).
4. His headquarters shall be Puducherry.
5. He shall be entitled to TA/DA while out on duty as eligible to Class-I officers of the rank of Deputy Secretary in the Central Government.

6. He shall be entitled to 12 days casual leave in a calendar year.
